2018 Budget Discussion Summary led by Hilary Swenson

- Expecting to end 2017 very close to budget.
- Overall, the 2018 assessments remain the same as 2017. The operating assessment increases \$1,302 and the painting assessment is reduced by the same amount. The reserve assessment remains the same.
- There is a new expense line in the 2018 budget for roof repairs and maintenance.
- The 2017 estimated year-end reserve fund balance is \$47,855 but could change depending on the 530 roof project outcome.
- The 2017 estimated year-end painting fund balance is \$20,860.

<u>Motion by Tommy Lusk, seconded by Jerry Petrow,</u> to approve the 2018 Proposed Budget as presented. *Motion passed unanimously.*

Board of Director Nominees

Jerry Petrow's seat is expiring, 3-year term.

Jerry Petrow is willing to serve for another term and was nominated by Trent Hein.

An election will be held at the owners meeting in December.

Motion by Tommy Lusk, Seconded by Jerry Petrow, to obtain at least two bids whenever possible on any HOA projects above \$10,000.00. *Motion passed unanimously.*
