- ~There is a new expense line in the 2018 budget for roof repairs and maintenance.
- ~The 2017 estimated year-end reserve fund balance is \$47,855.
- ~ The 2017 estimated year-end painting fund balance is \$20,860.

1. To reduce the Reserve Fund gate project expense to \$12,750.
